Blockchain Breakout Session A

Discussion Topic: Borrower Id Verification

The focus of this breakout will be around the acquisition of a borrower from potential to prospect to pipeline. The challenges here are in identify verification in part, but also obtaining the information as the potential borrower may interrogate online listing, take part in open houses, etc. How to solve the challenge of getting data about those self-service market situations from the portals and ensure you have a lock on the right borrower.

Discussion Topic: Single Source of Truth - Increase transparency through document collaboration

The Origination process requires collaboration of data and document from many parties which is often fraught with poor coordination and disconnects on the final version of data and documents. The goal is to explore the capabilities of blockchain to serve as a single source of truth for Origination Loan Data / Document Collaboration and Shared Database to increase transparency to all parties, reduce compliance challenges created by invalid or conflicting data and documents, and reduce the cost and time to originate a mortgage.

Discussion Topic: Single Source of Truth – Digital Vault – Loan

The break out group challenge for origination / property occurs at the beginning of the mortgage process; that is exploring using blockchain as the single source of truth for all origination loan data and documentation that originators, investors, purchasers, or other interested parties may rely upon. When considering the activities associated with the asset over the course of its' remaining economic life, whether remaining on a lender's balance sheet, securitized, or actively purchased and sold, blockchain may prove to be an attractive solution to capturing, securing and confirming information in an immutable and auditable format for use.

Blockchain Breakout Session D

Discussion Topic: Property

The challenge with property is how to capture, coordinate, and securely provision all the various data aspects of property for all interested and authorized parties. Currently the commonly

considered source of truth for information on real property in the US is established by statute within each state and typically involves a registrar for each county. Establishing clear title, and understanding the history of a particular piece of real estate can be time consuming and expensive, and the data can be incomplete or inconsistent from a Housing Finance perspective. How can we leverage the MISMO Standard and Blockchain technology to improve the situation?

In this breakout session we will explore the concept of using a distributed ledger that captures information on a piece of real property that records every transaction or change to that property in perpetuity. Think of replacing all the various county registrars, etc. with a ledger that works for a much larger jurisdiction such as a state – potentially all of the US. This could record lot information, building on the property, improvements (including permits), taxes and assessments, sales, references to mortgages, zoning and rezoning – and other things we haven't thought of yet. Using the concept of a geo hash to confidently identify a given property and align the various geocoding, identifying elements (construction type, # of bedrooms, Sq. Ft., etc) along with chain of title information, periodic valuations and inspections as well as any rehabs and repairs. Recording property inspections on the ledger may be one of many interesting use cases for this break out group.
